#### Lake Berryessa Revitalization Progress


Sun Outdoors continues to make progress in the permitting process for Steele Canyon Recreation Area and Spanish Flat Recreation Area. Hopefully, they'll begin construction at Steele Canyon soon. One decision they'll face is whether to keep the resort open during the massive construction that will take place or try to phase-in the project elements while keeping the resort open to the public.

Since the lake water level is so low and dropping, there probably won't be much demand for boat launching until the level rises again. This gives Sun the option of closing the resort and dedicating all their resources to constructing the new facilities. The originally scheduled Steele Canyon Resort reopening date is Summer, 2024. I personally wish to see development occur as rapidly as possible.






#### Lake Berryessa Statistics (10/31/22)


The lake is now down to 396.4 feet - 45.4 feet below Glory Hole. The level is now 14 inches below the lowest level reached during our last drought, 395.8' on December 9, 2015. Rainfall at Monticello Dam remains at 1.15 inches. The Gamble Gauge is at 51.4% capacity.

Surface water temperature has dropped to 67 degrees from the surface to 40 feet down. Temperature is around 58 degrees at 70 feet and below.





The weather is unpredictable, but Lake Berreyssa has recovered from three serious droughts in its history.

The Silliness of the Recall Effort Against Napa County Supervisor Alfredo Pedroza.

"Any end justifies any means"?

Supervisor Alfredo Pedroza can legitimately be called a strong proponent of the revitalization of Lake Berryessa and the Lake Berryessa community. He has been an enthusiastic supporter of the future of Lake Berryessa since I first met him and gave him a tour of the area when he was appointed supervisor by Governor Brown.

Proponents of the Pedroza recall point to his involvement with his in-laws' purchase of potential vineyard land near the controversial Walt Ranch vineyard project. Pedroza denied having a conflict but agreed to recuse himself from votes involving Walt Ranch after citizens brought the matter up. The Board of Supervisors redid the December vote without him and the Walt Ranch project was approved.

The group that wants Napa County Supervisor Alfredo Pedroza ousted from office before his term ends must gather 3,232 signatures by Feb. 9 to qualify a recall ballot measure. Registrar of Voters John Tuteur estimates the cost to the Napa County of a recall elction would be \$175,000 to \$250,000.

U.S. Rep. Mike Thompson, State Sen. Bill Dodd, and Assembly Member Cecilia Aguiar-Curry, wrote, "Don't sign the recall petition" in a September letter to the Napa Valley Register.

Those who follow Napa County politics understand that Napa is one of the most antidevelopment and "well-protected" counties in the state, if not the country. Groups and individuals use about any excuse to try to stop any proposed development such as large homes, and especially wineries. This was clear from the attempt to pass the Stream Setback Ordinance many years ago and the original Oak Woodlands Initiative, as well as the follow-up Napa Water Quality And Tree Protection Ordinance - all of which were defeated.

The Pedroza recall attempt is just another anti-development move (this one aimed at a winery - Walt Ranch) cloaked under an "anti-corruption" banner.

#### Seasonal Closures at Lake Berryessa

The Bureau of Reclamation has announced recreation area closures and new operating hours at Lake Berryessa beginning Sept. 25. These seasonal closures allow natural resource recovery as Reclamation performs necessary maintenance.

Reclamation-operated locations at Berryessa remain open year-round with the exceptions and hours listed below:

The north side of Oak Shores Day Use Area and the two restrooms along the Smittle Creek Trail are closed until March 31.

The south side of Oak Shores Day Use Area will continue to offer restroom facilities, picnic tables, water access and a kayak/canoe hand launch.

Gates will open at 7:30 a.m. and close at 5 p.m. to reflect daylight hours' changes at Oak Shores, Smittle Creek and Eticuera.

Capell Cove Boat Launch *area* will remain open from 4 a.m. to 10 p.m. The *launch ramp* remains closed to motorized boats until water levels rise again.

The Smittle Creek Trail and Lake Berryessa administrative offices are closed until further notice.

The Dufer Point Visitor Center and gates to day use areas will be closed on Thanksgiving and Christmas.

The Dufer Point Visitor Center at 5520 Knoxville Road is open Saturdays, Sundays, and most holidays (exceptions above), from noon to 3 p.m. beginning Oct. 1 through March 31.

Maps, information, and America the Beautiful and Lake Berryessa annual passes are available during operating hours.


